

Portions of James O'Neill's letter to HHS Secretary Tommy Thompson follow:

Secretary Thompson,

January 31, 2002

Based on your statement today "Regarding the approval of license Supplements for anthrax vaccine" I ask the following questions;

1. Does the Federal Law that states drugs or vaccines manufactured under less than (GMP) good manufacturing practices can not be used regardless of final testing processes mean anything to you, or your department?

2. As the military deprives it's members and the public of specific data on how many babies have been born with birth defects because of this vaccine do you feel it's wise to authorize three lots? and to announce it before it is tested or reviewed per your official statement?

3. Will you, or the F.D.A. use this vaccine as your F.D.A., the military, and Bioport indicated when submitting a 77 page Investigational New Drug Application in 1996? An I.N.D. that was aborted?

4. Will you permit General Cain to have his way with your F.D.A. and final testing as was done while our soldiers were made sick with this contaminated poison?

5. Will the Department of Defense continue to opine **BOLDFACED LIES** that veterinarians have used this for decades? (**ABSOLUTELY FALSE**)

6. Will the baby doctor that knows nothing about anthrax be in charge of the vaccine use, **AGAIN**?

7. Have you met any of the country's most patriotic soldiers that will be sick for life after being forced to accept this vaccine, or go to jail?

8. Have you met any of our fine young soldiers that were given "DISHONORABLE DISCHARGES" because they know this vaccine is illegal, untested, unclean and harmful?

9. Have you read any testimony before Congress that this vaccine causes double vision, blurred vision, memory loss and blackouts? This was a common testimony by dozens of soldiers that I met.

...Do you believe a military officer (a pilot) that stated; "This vaccine will maim and kill more United States pilots than Saddam ever dreamed that he could?" The pilot has already been proven correct.

... Do you believe it's in the interest of our country to release three lots of 5,000,000 doses made by a factory that has failed six full FDA inspections while never passing one? While Veterans Affairs just announced our Gulf War Heroes are 2.7 times more likely to die a slow agonizing miserable death from ALS? while 700,000 "lost" medical records caused 110,000 soldiers to suffer **TEN YEARS** undiagnosed?

... Do you feel in your heart that a soldier and/or a soldier's parents should have no legal rights, due to the **FERES** Doctrine, if they suffer

serious permanent injury from this AWFUL, UNCLEAN, UNTESTED, ILLEGAL, LIED
